PATENT ASSIGNMENT

3. Assignor hereby requests that the U.S. Commissioner of Patents and Trademarks and/or the applicable foreign authorities record this Assignment, as to the Assigned Patent herein referred to.
4. All questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Assignment shall be governed by the laws of the State of New York, regardless of the laws that might otherwise govern under applicable principles of conflict of laws.

5. Assignor will execute any and all additional documents and take other action as may be necessary or desirable to record or memorialize the assignment of the Assigned Patent set forth herein, in the United States or other foreign jurisdictions, as applicable, and to vest in Assignee such right, title, and interest in and to the Assigned Patent as granted to Assignee.
