Releasor further agrees to execute and deliver to Releasees any and all further documents or instruments and do any and all further acts which Releasees (or Releasees' agents or designees) reasonably request in order to confirm Releasees' right, title and interest in and to the Patents, and that Releasor makes no further claim to any right, title or interest in or to any of the Patent Collateral pertaining to the Patents .




