



- (B) 转让人同意按下列条款，将所述外观设计的所有权利转让给受让人，及执行此转让。


据此，双方现协议如下：

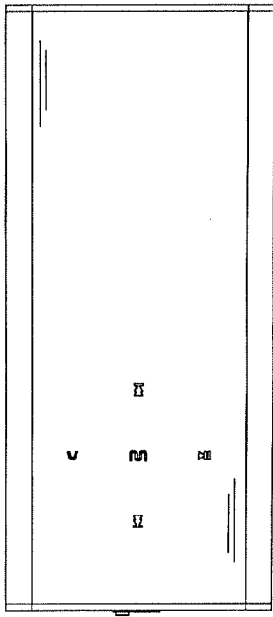

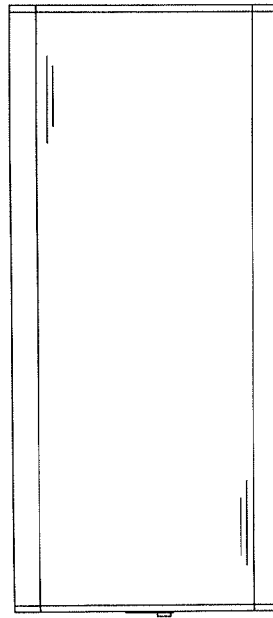

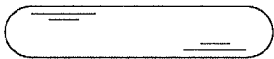

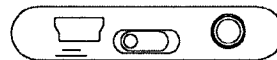

ASSIGNMENT

THIS ASSIGNMENT is made on the 2nd day of January, 2007

BETWEEN

(1) DAI Zewu, a citizen of the People's Republic of China of ROOM 11E, BLOCK 13, YIKOU HUAYUAN CITY, NANSHAN DISTRICT, SHENZHEN CITY, PEOPLE'S REPUBLIC OF CHINA ("The Assignor")

and

(2) SHENZHEN HONGTIANTAI ENTERPRISE CO., LTD., a limited liability company incorporated under the laws of the People's Republic of China of FLOOR 4, ZHENXING INDUSTRIAL BUILDING, NO. 159 MEIHUA ROAD, SHANGMEILIN, FUTIAN DISTRICT, SHENZHEN CITY, PEOPLE'S REPUBLIC OF CHINA ("The Assignee")

WHEREAS

- (A) The Assignor created a design for MP3 Players ("the Design"). Representations of the Design are annexed hereto in Attachment A.
- (B) The Assignor has agreed to assign all rights in the Design to the Assignee on the terms set out herein and to execute this Assignment.

IT IS AGREED as follows:

- 1. In consideration of the sum of RMB\$1 (receipt of which the Assignor hereby acknowledges), the Assignor as beneficial owner hereby sells, assigns and transfers to the Assignee the full and entire rights, title and interests in the Design for which an application for United States Patent was executed on the date hereof and may be granted therefor, to the full end of the term for which the said patent may be granted, as fully and entirely as the same would have been held by the Assignor had this Assignment not been made, together with the right to sue for past infringements of any such right and to retain any damages obtained as a result of such action.
- 2. This Assignment shall be governed by and construed in accordance with the laws of the People's Republic of China and the parties hereby submit to the non-exclusive jurisdiction of the courts of the People's Republic of China.
