ASSIGNOR hereby agrees to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEE, its successors, assigns and legal representatives, when deemed reasonably necessary or appropriate to ASSIGNEE's, its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such invention and rights hereby transferred.

ASSIGNOR furthermore agrees upon request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, to execute any and all papers desired by ASSIGNEE, its successors, assigns and legal representatives, for the filing and granting and maintenance of said patent and all related U.S. and foreign applications and patents and the perfecting of title thereto in said ASSIGNEE, its successors, assigns and legal representatives.
