Assignor hereby covenants that he has the full right to convey the entire interest assigned herein and has not executed and will not execute any agreement in conflict herewith.


## ASSIGNMENT I

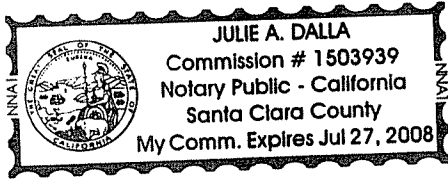


