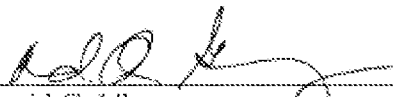
ASSIGNMENT OF APPLICATION

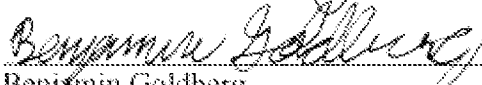
