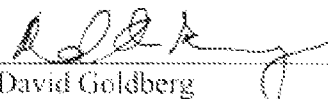
ASSIGNMENT OF APPLICATION

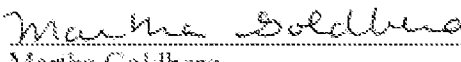

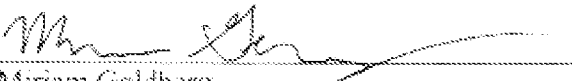

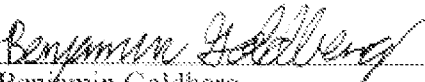
