UNITED STATES PATENT ASSIGNMENT

WHEREAS, Christopher Danks of York, Great Britain and Jonathan Richard Flint of York, Great Britain; (hereinafter referred to as "ASSIGNOR"), owns an invention (the "INVENTION") relating to an improvement in ANALYTE DETECTION SYSTEM and has executed an application for a United States patent based thereon (serial number 11/571,481 filed December 29, 2006) (114290) (the "APPLICATION");

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had no sale and assignment of said interest been made;

AND ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said INVENTION or any part thereof, to said ASSIGNEE;

AND ASSIGNOR, his successors and assigns, hereby agrees to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by said ASSIGNEE fully to secure to said ASSIGNEE its interest as aforesaid in and to said INVENTION or any part thereof, and in and to said several patents or any of them;


