## ASSIGNMENT

AND, MGL HEREBY further covenants that MGL has the full right to convey the interest assigned by this Assignment, MGL will take all action and execute all documents necessary to perfect the interest assigned hereby, and MGL has not executed and will not execute any agreement in conflict with this Assignment;

AND, MGL HEREBY further covenants and agrees that MGL, through its officers and employees, will, without further consideration, communicate with MRP, its successors and assigns, any facts known to MGL and its officers and employees respecting the inventions and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the inventions in said MRP, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything possible to aid MRP, its successors and assigns, to obtain and enforce proper patent protection for the inventions in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by MRP, its successors and assigns.
