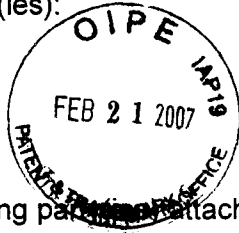

And we do hereby authorize and request the Commissioner of Patents to issue all Letters Patent which may be granted upon any of the applications, to Imation Corp., as the assignee of the entire right, title, and interest therein.




