Assignor does hereby agree to execute any lawful document and to testify as to any material fact or thing which is necessary to secure unto Assignee the full right, title and interest in and to the Scheduled Patents.

IN WITNESS WHEREOF, Assignor has executed and delivered this instrument to Assignee on the date first noted above, and Assignee acknowledges receipt of the same.


