WHEREAS, I represent and warrant that I am the sole owner of said invention and application for Letters Patent; and,


and (c) all United States and foreign patents which shall issue on said invention, including all reissues, renewals, divisions and extensions thereof, for the United States, its territories and possessions and all foreign countries, including the right to file applications for Letters Patent on said invention in any and all foreign countries, the same to be held and enjoyed by said ASSIGNEE, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by me, had this Assignment and sale not been made.

ASSIGNOR further covenants with ASSIGNEE that the rights and property herein conveyed are free and clear of any encumbrances, and that ASSIGNOR has the full right to convey the same as herein expressed.
