ASSIGNMENT

WHEREAS, we, TOM SCHÖNHERR, Argonnenstr. 22, D-70374 Stuttgart, Germany, and FABIAN KOLLMANN, residing at Hoffeldstr. 57, D-70597 Stuttgart, Germany, have invented a new original and ornamental design for a SHOWER HEAD FACE for which we have made application for Letters Patent of the United States of America; and
