ASSIGNOR does hereby covenant and agree to provide any tangible property embodying or describing the invention, including, without limitation, all **PATENT** documents,

drawings, prototypes, models, test results, designs, materials, computer programs and data, and the like, which, if not presently in the possession of ASSIGNEE will be delivered to ASSIGNEE immediately upon request;

ASSIGNOR does hereby covenant and agree to do everything possible to aid ASSIGNEE, their successors, legal representatives and assigns to obtain and enforce proper patent protection for the invention in all countries including assisting with the preparation of any application relating to the invention;

ASSIGNOR does hereby covenant and agree not to contest the validity or enforceability of any intellectual property rights assigned herein, or to assist or request any third party to contest the validity or enforceability of any intellectual property rights assigned herein;

ASSIGNOR does hereby release and forever discharge ASSIGNEE from any and all claims, including but not limited to any debts, liabilities, damages and causes of action of whatsoever kind or nature relating to the invention, whether or not known, suspected and unsuspected, including any and all previous agreements entered into, which now exist, or may have existed prior to the date of this assignment.

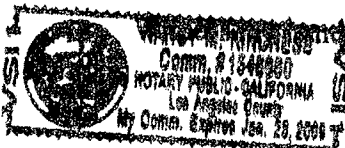
