The undersigned also hereby appoints ASSIGNEE as its common agent for purposes of prosecuting international patent applications and any material patent applications for which such common agency is recognized.

The undersigned hereby requests the Honorable Commissioner of Patents and Trademarks to issue said Letters Patent and any and all divisions, continuations, continuations-in-part, and reissues thereof to said ASSIGNEE.


