ASSIGNMENT

WHEREAS WE, EDWARD B. MCCAULEY of 1206 Tremont Drive, Cedar Park, Texas 78613; and, SCOTT T. understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of both parties.

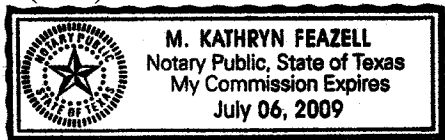
