ASSIGNMENT

We, William T. Dalebout, Gaylen W. Ercanbrack, and N. Jeffrey Chatterton of Utah, have invented a method and apparatus entitled ONE-STEP FOLDABLE ELLIPTICAL EXERCISE MACHINE, hereinafter called the "invention."


Cooperation to the best of my ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.
