ASSIGNMENT

WHEREAS, I, **CHI GON CHEN**, ASSIGNOR, residing at Sha Xi Industrial, Jiang Gao Town, Bai Yun Interval, Guang Zhou, China, and citizen of the People's Republic of China, am the sole inventor of the invention entitled "**High Intensity Outdoor Light Fixture**," a drawing of which is attached hereto as Exhibit "A" and incorporated by reference as if fully set forth herein; and

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) to the said ASSIGNOR in hand paid, and for other good and valuable consideration, the receipt of which is hereby acknowledged, I, the said ASSIGNOR, have sold, assigned, transferred, and set over, and by these presents do hereby sell, assign, transfer, and set over, unto the said ASSIGNEE, its successors, legal representatives, and assigns, my entire right, title, and interest in, to, and under the said invention, and the said patent application, and all divisions, renewals, and continuations thereof, and all patents of the United States which may be granted thereon and all reissues thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said applications under the Patent Laws of the United States and the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such applications are filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, and design which may be granted for said invention in any country or countries foreign to the United States, and all extensions, renewals, and reissues thereof;

I FURTHER HEREBY authorize and request the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States,

whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument;

I FURTHER HEREBY covenant that I have full right to convey my entire interest herein assigned and that I have not executed, and will not execute, any agreement in conflict herewith;

I FURTHER HEREBY convent and agree that I will communicate to the said ASSIGNEE, its successors, legal representatives, and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said invention in all countries.

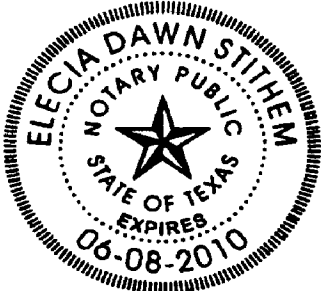
