CERTIFICATE

The Commercial Register Office of the Canton of Aargau (Switzerland) hereby certifies:

- As a result of a merger, **Sprecher & Schuh AG**, which is domiciled in Aarau and was founded on April 15, 1908, took over the assets and liabilities of the company "Maxim A.G. Fabrik für thermo-elektrische Apparate" [Maxim A.G. Factory for Thermo-Electrical Devices], in Aarau (official company register NF VIII 186), according to the balance sheet as of November 30, 1970, and the merger agreement of December 23, 1970.
- According to the articles of association of April 25, 1986, the company changed its name to **Sprecher Energie AG**, new headquarters in Oberentfelden (CH-400.3.925.055-0).
- According to the articles of association of November 24, 1993, the company changed its name to **GEC Alsthom T&D AG**.
- Merger: The company took over by means of a merger, pursuant to Art. 748 of the Swiss Federal Code of Obligations [OR], "GEC Alsthom Sales Network SA" in Oberentfelden (CH-400.3.018.439-0). The assets of CHF 27,055,355.00 and the liabilities of CHF 23,731,128.00 were transferred, according to the merger agreement of July 29, 1997, and the merger balance sheet as of March 31, 1997, by universal succession to the company, which already owned all of the shares of the company that was taken over. In so doing, these shares lapsed; and the share capital of the acquiring company remained unaffected.
- At the same time the company changed, according to the articles of association of July 29, 1997, its name to **GEC Alsthom AG** and then, according to the articles of association of June 10, 1998, to **ALSTOM AG**, in Oberentfelden.
- Merger: The company took over by means of a merger, pursuant to Art. 748 OR, "ALSTOM T&D Systems AG" in Oberentfelden (CH-400.3.010.783-0). The assets of CHF 53,041,616.92 and the liabilities of CHF 42,688,723.10 were transferred, according to the merger agreement of June 1, 1999, and the merger balance sheet as of March 31, 1999, by universal succession to the company, which already owned all of the shares of the company that was taken over. In so doing, these shares lapsed; and the share capital of the acquiring company remained unaffected.

- The result of the resolution passed by the shareholders at the general meeting on December 22, 2000, was that **ALSTOM AG** in Oberentfelden (CH-400.3.925.055-0) was dissolved and deleted [in the Commercial Register], as a consequence of a merger, pursuant to Art. 748 OR, with “ALSTOM Power (Switzerland) AG,” currently **ALSTOM (Switzerland) AG**, in Baden (CH-400.3.008.848-1). The assets and the liabilities were transferred to “ALSTOM Power (Switzerland) AG,” currently **ALSTOM (Switzerland) AG**, in Baden (CH-400.3.008.848-1).
