ASSIGNMENT

WHEREAS, we, Kevin McAllister (resident of American Fork, UT, whose postal mailing address is 295 West 1450 North, American Fork, UT 84004), and Bryce Doman (resident of Lehi, UT, whose postal mailing address is 530 West 300 North, Lehi, UT 84043) (hereinafter "Assignors") have invented a certain new and useful improvement in ADJUSTABLE HEIGHT BASKETBALL HOOP for which an application for United States Design Letters Patent was filed on January 25, 2007 as THORPE NORTH & WESTERN L.L.P. Docket No. 2450-003.DES, and given U.S. Design Patent Application Serial No. 29/271,840; and;

prosecute U.S. and foreign patent applications on said invention, and to do so in its own name wherever such right may be legally exercised, and including the right to claim the priority and benefits of the International Convention for such applications; and the right to bring actions for infringement of any right in said invention in its own name, including past infringement, in any jurisdiction.

We hereby authorize and request the United States Commissioner of Patents and Trademarks, and such Patent Office officials in foreign countries as are duly authorized by their patent laws to issue patents, to issue any and all Design Letters Patent on said invention to the said Assignee as the owner of my entire interest, for the sole use and behoof of the said Assignee, its successors, assigns and legal representatives, to the full end of the term for which said Design Letters Patent may be granted, as fully and entirely as the same would have been held by us had this assignment and sale not been made.

We hereby agree, without further consideration and without expense to us to sign all lawful papers and to perform all other lawful acts which the Assignee may request of us to make this Assignment fully effective, including, by way of example but not of limitation, the following: prompt execution of all original, divisional, substitution, reissue, and other United States and foreign patent applications on said invention, and all lawful documents as requested by the Assignee to further the prosecution of any of such design patent applications; cooperation to the best of my ability including, but not limited to, the execution of all lawful documents, the production of evidence in any actions or proceedings concerning the invention, including, but not limited to, nullification, reissuing, extension, and infringement proceedings involving said invention.


