PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT is made and entered into as of February 28, 2007, by and between Celanese Chemicals Europe GmbH, Celanese GmbH, Hoechst AG, Clariant GmbH (each an "Assignor", and collectively the "Assignors"), and Drachenfelssee 521. V V GmbH, to be renamed Oxea Deutschland GmbH ("Assignee").

WHEREAS, the parties are subject to a Purchase Agreement dated as of December 12, 2006 (the "**Purchase Agreement**"), which requires that the parties hereto enter into this Patent Assignment;

WHEREAS, Assignors are the owner of the patents and patent applications set forth on Schedule A hereto (the "Patents"); and

WHEREAS, Assignee desires to acquire all of Assignors' right, title and interest in and to the Patents and the Assignors is willing to assign the Patents to Assignee;

NOW THEREFORE, in consideration of the above premises, the mutual covenants contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignors hereby convey, assign, transfer and deliver to Assignee, its successors and assigns, all of their right, title and interest throughout the world in, to and under the Patents, together with the right to file for United States or foreign reissues, divisions, renewals, extensions, provisionals, continuations and continuations-in-part thereof, and substitutes therefor, and all letters patent of the United States which have been or may be granted thereon and all foreign counterparts thereof, together with the right to sue and recover damages for future or past infringements of the Patents and to fully and entirely stand in the place of Assignors in all matters related thereto.

2. At Assignee's request from time to time, and at Assignee's expense, Assignors agree to execute any appropriate, necessary and customary additional documents and to take such other actions as may be necessary or appropriate to transfer to Assignee their entire right, title and interest in and to the Patents.

3. Assignors hereby requests the U.S. Commissioner of Patents and Trademarks (the "Commissioner") and the applicable foreign patent authorities to record this Patent Assignment to Assignee. Assignors hereby further requests the Commissioner and the applicable foreign patent authorities to issue any and all letters patent derived from the Patents to Assignee as assignee of the entire interest.

4. All questions concerning the construction, validity and interpretation of this Patent Assignment and the performance of the obligation imposed by this Patent Assignment shall be governed by the laws of the State of New York, regardless of the laws that might otherwise govern under applicable principles of conflict of laws.

5. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of other Patents.

6. This Patent Assignment is executed in connection with and subject to the terms and conditions of the Purchase Agreement. As between Assignors and Assignee, nothing in this Patent Assignment shall be deemed to modify any agreements as between Assignors and Assignee as provided for in the Purchase Agreement.
