PARTIES

- (1) **REALISATIONS 234 LIMITED** (formerly known as **THE LONDON TIFFIN COMPANY LIMITED**) (a company incorporated in England and Wales with registered number 4435885) whose registered office is at 12 Great James Street, London WC1N 3DR ("**Assignor**"); and
- (2) **GOURMET RESTAURANTS LIMITED** (a company incorporated in England and Wales with registered number 5469829) whose registered office is at 12 Great James Street, London WC1N 3DR ("**Assignee**").

RECITALS

- (A) The Assignor is the proprietor of the registered designs listed in the attached Schedule ("**Designs**").
- (B) By a Sale and Purchase Agreement dated 24 June 2005 between the Assignor and the Assignee, the Assignor has agreed to assign all its rights, in and to the Designs to the Assignee on the terms set out below.

OPERATIVE PART

1. Assignment

In consideration of the sum of £1 now paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns with full title guarantee to the Assignee absolutely the Designs and all and any rights in and to the Designs and any common law rights and all the goodwill attaching to the Designs.

2. Proceedings

This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Designs (including proceedings against any third party for infringement of the Designs or for passing off or for otherwise infringing the rights of the Assignor in the Designs). The Assignor agrees and undertakes to provide to the Assignee (at its request) all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Designs and the Assignee shall indemnify the Assignor in respect of all costs and expenses (including reasonable legal costs) actually incurred by it in providing the Assignee with such assistance.

3. Further assurance

The Assignor covenants that at the cost and request of the Assignee at any time and from time to time it shall execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this assignment.

4. Governing law and jurisdiction

This assignment shall be governed by and construed in accordance with the laws of England and the parties hereto submit to the exclusive jurisdiction of the English courts.
