ASSIGNMENT

WHEREAS, Ning Cui, residing at 1026 Ledgewood Trail, Lyndhurst, Ohio 44124, Urs Krebs, residing at 282747 Brockway Drive, Westlake, Ohio 44145, and Peter R. 


