2. Assignor authorizes and requests the Commissioner of Patent and Trademarks to record Assignee as owner of the Patent, including any divisions, reissues, reexaminations or extensions thereof or continuations or continuations-in-part, and to issue any and all letters patent of the United States and any foreign jurisdiction thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same, for


the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.
