

ASSIGNMENT

WHEREAS, I, DONG WOOG SEO, residing at Samsung Myounga Apartment 215-085, Paho-dong, Dalseo-gu, Taegu, Republic of Korea, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **SIDE RAIL ASSEMBLY FOR A CANOPY**, and executed by me on even date herewith, together with claim to the priority of Korean Utility Model Application No. 2003-0001544 filed January 17, 2003 and registered as Korean Utility Model Registration No. 0312123 on April 21, 2003;

WHEREAS, CARAVAN INTERNATIONAL CO., LTD. is a corporation organized and existing under the laws of the Republic of Korea having its principal place of business at 100-39 Galsan-dong, Dalseo-gu, Taegu, Republic of Korea (hereafter, together with any successors, legal representatives or assigns thereof, and Dong Woog Seo, called "ASSIGNORS");

AND WHEREAS, CARAVAN CANOPY INTERNATIONAL, INC., a California Corporation, having a place of business at 2111 S. Acacia Avenue, Compton, California 90220 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEE") has acquired and wants to acquire the entire right, title and interest in and to said improvements and application (except for such right, title and interest in and to the improvements in the Republic of Korea and Japan).

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to ASSIGNORS in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNORS have sold, assigned, transferred and set over, and do hereby sell, assign, transfer and set over to ASSIGNEE the entire right, title and interest in and to said improvements (except for such right, title and interest in the Republic of Korea and Japan), and said application and all divisions and continuations thereof, and all United States Letters Patents which may be granted thereon and all reissues, reexaminations and extensions thereof, and all priority rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country (except for such priority rights to be claimed in applications filed with Korean and Japanese Patent Offices), and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries (except the Republic of Korea and Japan), and all patents (including all continuations, divisions, extensions, renewals, substitutes, and reissues thereof) granted for said improvements in any foreign countries (except the Republic of Korea and Japan); and ASSIGNORS hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries (except the Republic of Korea and Japan) whose duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to ASSIGNEE in accordance with the terms of this Assignment;

AND ASSIGNORS HEREBY covenant that ASSIGNORS have full right to convey the entire interest herein assigned, and that ASSIGNORS have not executed, and will not execute, any

agreement in conflict herewith.

AND ASSIGNORS HEREBY further covenant and agree that ASSIGNORS will communicate to ASSIGNEE any facts known to ASSIGNORS respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries (except the Republic of Korea and Japan).
