ASSIGNMENT

WHEREAS, WE, ANDREAS CHRISTEL, a citizen of Switzerland and a resident of Zuzwil, Switzerland and CLAUDEMIRO FERREIRA a citizen of Brazil and a resident of Pocos de Caldas, Brazil, have invented new and useful improvements in MANUFACTURE OF A HIGH MOLECULAR POLYCONDENSATE for which an application for United States Patent Application and Letters Patent was executed on even date herewith..

AND WE FURTHER covenant and agree, in consideration of the premises, that we or our executors and administrators, will at any time upon request communicate to the said

BÜHLER AG, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to us or to our executors and administrators, and that we will testify as to the same in any interference or other litigation when requested so to do by the said BÜHLER AG, it being understood that, BÜHLER AG will compensate us for our expenses reasonably incurred in complying with its requests.
