ASSIGNMENT OF PATENT APPLICATION

WHEREAS, the undersigned, Yeo Boon Khee, a resident of Block 8 #21-55, Kim Tian Place, Singapore 163008, hereinafter referred to as Assignor, has co-invented certain new and useful improvements in an invention entitled SEPARATED GRAY METAL AND TITANIUM NITRIDE SOLAR CONTROL MEMBERS, for which an application for Letters Patent was filed in the United States Patent and Trademark Office on September 21, 2006 and assigned Application No. 11/524,992;

which may be incurred by said Assignor in lending such assistance and cooperation shall be paid by the Assignee.

3. The terms, covenants and conditions of this assignment shall inure to the benefit of said Assignee, its successors, assigns and/or other legal representatives, and shall be binding upon said Assignor, his heirs, legal representatives and assigns.
