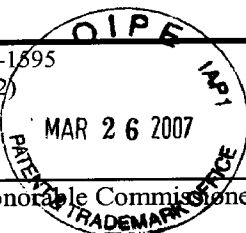

ASSIGNMENT

AND **ASSIGNORS** DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent, when granted, to **ASSIGNEE**, its successors and assigns, as assignees of the entire right, title and interest in and to said improvements, for the sole use and benefit of said **ASSIGNEE**, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

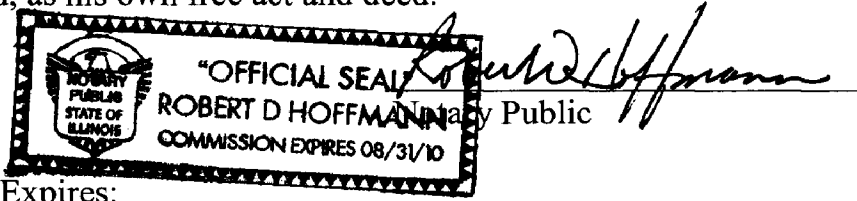

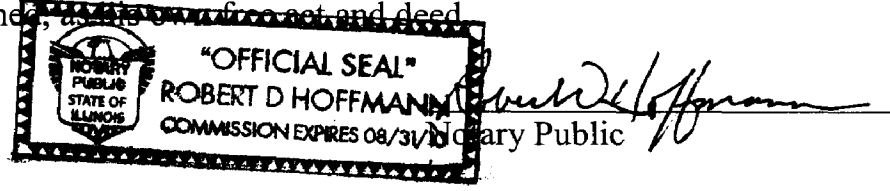
