ASSIGNMENT OF PATENT RIGHTS


For valuable consideration, the receipt and sufficiency of which is hereby acknowledged, on this 16th day of April, 2007, John Leslie Perkins residing at 13 Mitford St., St. Kilda, Victoria 3182, Australia ("Assignor"), to ensure that the assignment executed on April 18, 2001 recorded at reel/frame 013556/0631, is completed, hereby sells, assigns, and transfers to Exfax Technologies Pty Ltd., an Australia company ("Assignee"), the full extent of the right, title, and interest in and to any and all of the following (collectively, the "Rights"):

1. U.S. Patent 6,614,889 ("the U.S. Patent") that was filed as U.S. Application 09/837,965, claiming priority to Australian Provisional AU PQ703200A;
2. All inventions claimed or described in the U.S. Patent (collectively, "the Inventions");
3. All rights with respect to the Inventions, including all U.S. patents or other governmental grants or issuances that may be granted with respect to the Inventions, or from any direct or indirect divisionals, continuations, continuations-in-part, or other patent applications claiming priority rights from the U.S. Patent ("Potential Patents");
4. All reissues, reexaminations, request for continuing examination, extensions, or registrations of the U.S. Patent or Potential Patents;
5. All non-United States patents, patent applications, and counterparts relating to any or all of the Inventions, the U.S. Patent, or Potential Patents, including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances ("Foreign Rights"), and including the right to file foreign applications directly in the name of Assignee, its successors and assigns;
6. The right to claim priority rights deriving from the U.S. Patent;
7. All causes of action and remedies related to any or all of the U.S. Patent, the Inventions, Potential Patents, or Foreign Rights (including, without limitation, the right to sue for past, present, or future infringement, misappropriation or violation of rights related to any of the foregoing and the right to collect royalties and other payments under or on account of any of the foregoing); and
8. Any and all other rights and interests arising out of, in connection with, or in relation to the U.S. Patent, the Inventions, Potential Patents, or Foreign Rights.

Assignor will not sign any writing or do any act conflicting with this Assignment, and, without further compensation, will sign all documents and do such additional acts as Assignee, its successors, legal representatives, and assigns deem necessary or desirable to perfect enjoyment of the Rights, conduct proceedings regarding the Rights (including any litigation or interference proceedings), or perfect or defend title to the Rights. Assignor requests the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models, or other governmental grants or issuances that may be granted upon any of the Rights in the name of the Assignee, as the assignee to the entire interest therein.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, legal representatives, and assigns and will be binding upon Assignor, his successors, legal representatives and assigns.


