ASSIGNMENT

Now, therefore, to all whom it may concern, be it known that, for and in consideration of the covenants herein contained, the parties hereto, intending to be legally bound, agree as follows:



2. MPA International Corporation hereby grants this Assignment in consideration of collateral understandings.
3. MPA International Corporation hereby agrees that its legal representatives will make, execute and deliver any and all instruments in writing, including any further affidavits, assignments and other documents, to more effectually secure to, and vest in, MAGICC, LLC and its assigns the entire right, title and interest in and to THE INVENTION, said patent, all inventions and improvements encompassed within the disclosure of the patent, and all reissues and extensions of the patent.
4. MPA International Corporation will communicate to MAGICC, LLC and its representatives all facts known to it relating to THE INVENTION, the patent and all inventions and improvements encompassed with the

disclosure of the patent, and testify in all legal proceedings relative thereto.

5. MPA International Corporation hereby covenants and agrees that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made by it, and it has the full right to convey and assign the interests hereinabove mentioned.
6. MAGICC, LLC does hereby accept the transfer to it of THE INVENTION, the patent and all inventions and improvements encompassed within the disclosure of the patent.
7. This Assignment and the Acceptance thereof are made in, and shall be interpreted in accordance with the laws of, the State of Minnesota together with federal laws pertaining to United States patents.
8. Should any part of this Assignment be held invalid, illegal or void, the remainder hereof shall continue in full force and effect as if the invalid, illegal or other void provisions had never been included.


