AND I/we covenant and warrant that I/we have full right to convey the entire right, title and interest in this invention free and clear of all licenses, encumbrances or liens, and that I/we have not executed and will not execute any instruments in conflict with this agreement.

AND I/we agree that I/we, my/our executors, administrators, or other personal representatives, shall do whatever is legally necessary (make all rightful oaths, execute, and deliver any and all other instruments in writing, and any and all further applications, papers, powers, affidavits, assignments, disclaimers and other documents) in the opinion of counsel for the COMPANY, to secure and vest in the COMPANY, the entire right, title and interest in this invention, inventions, or improvements, application or applications, patents, rights, titles, benefits, privileges and advantages.
