ASSIGNMENT

WHEREAS, I, ALLYN E. PHILLIPS, a citizen of the United States and resident of 504 Plantation Drive, Simpsonville, South Carolina 29681, have invented certain new and useful improvements in ADAPTABLE MOUNTING ARRANGEMENT FOR SHAFT-CARRIED SPEED REDUCER as described in a patent application for U. employment; also the entire right, title and interest in and to any and all patents or reissues or extensions thereof to be obtained in this or any foreign country upon said invention, inventions, or improvements and any divisional, continuation, continuation-in-part or substitute applications which may be filed upon said invention, inventions, or improvements in this or any foreign country, and I hereby authorize and request the issuing authority to issue any and all patents on said application or applications to said RELIANCE ELECTRIC INDUSTRIAL COMPANY, as assignee of the entire interest.

I further agree, without any payment by RELIANCE ELECTRIC INDUSTRIAL COMPANY, other than expenses incurred by the undersigned, to communicate to said RELIANCE ELECTRIC INDUSTRIAL COMPANY, its representatives or agents, any information relating to said invention, or inventions or improvements, including evidence for interference purposes or for other legal proceedings, whenever requested; and to execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective.
