ASSIGNMENT

WHEREAS, We,

Tsz Yin YUM, a citizen of China, residing in Hong Kong, China;

Quan XUE, a citizen of China, residing in Hong Kong, China; and

Chi Hou CHAN, a citizen of the United States of America, residing in Hong Kong, China

have invented certain new and useful improvements in

HIGH EFFICIENCY LINEAR RF AMPLIFIER

AND WE HEREBY covenant that We have full right to convey the entire interest herein assigned, and that We have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that We will communicate to the said City University of Hong Kong, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said City University of Hong Kong, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
