aforesaid, to issue all Letters Patent for said inventions to the said **Inventors** its successors, legal representatives and assigns, in accordance with the terms of this instrument.

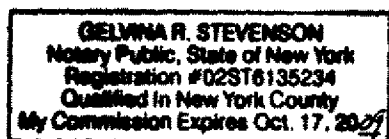
