## Assignment of Invention and Patent Application

THIS AGREEMENT dated APR 12 2007 is made BETWEEN :

ASUSTeK COMPUTER INC., a corporation incorporated under the laws of the

- (4) any applications which are continuations, continuations-in part, substitutes, divisions and extensions of the above-identified application.




