ASSIGNMENT AND AGREEMENT

Barker, Jr., Orlando, Florida,** (hereinafter ASSIGNOR), have sold, assigned and transferred, and do hereby sell, assign and transfer, unto MeshNetworks, Inc., a corporation duly organized under the laws of the State of Delaware, United States of America, with its principal place of business located at 485 North Keller Road, Suite 250, Maitland, Florida 32751-7535, United States of America (hereinafter ASSIGNEE), and its successors, assigns, and legal representatives, the entire right, title and interest for the United States of America in and to certain inventions relating to an improvement in **SYSTEM AND METHOD FOR PROVIDING QUALITY OF SERVICE PROVISIONS AND CONGESTION CONTROL IN A WIRELESS COMMUNICATION NETWORK** (Docket No. **MESH118**), described, illustrated and claimed in an application for Letters Patent of the United States of America executed by us on the dates indicated by our signatures below, together with the entire right, title and interest in and to the application, and in and to Letters Patent which may be issued upon the application, and upon any division, extension, continuation or reissue thereof.

We hereby authorize and request the Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation or reissue, to MESHNETWORKS, INC., for the sole use and benefit of MESHNETWORKS, INC., its successors, assigns and legal representatives, to the full end of the term for which Letters Patent may be granted, the same as they would have been held and enjoyed by me had this assignment not been made, and we hereby authorize and request the equivalent authorities in foreign countries to issue the patents of their respective countries to MESHNETWORKS, INC.

We agree that, when requested, we will, without charge to MESHNETWORKS, INC., but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for the inventions in any and all countries and for vesting title thereto in MESHNETWORKS, INC., its successors, assigns and legal representatives or nominees.

We covenant with MESHNETWORKS, INC., its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance.


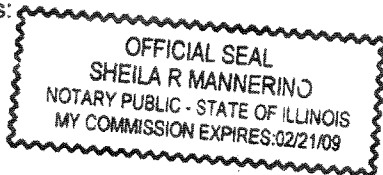
