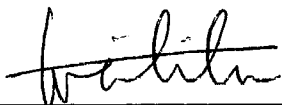
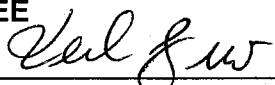
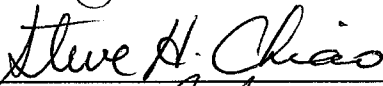
2. Said Assignors hereby covenant and agree to cooperate with said
