ASSIGNMENT OF PATENT RIGHTS

THIS AGREEMENT ("Agreement") is made and entered into as of the 2 day of March 2007, by A. L. "PEPPER" AASGAARD, of 3623 Armbrust Drive, Omaha, Nebraska 68124 ("Inventor") and ASAR GROUP, INC., a Nebraska corporation, ASAR TOOL, INC., a Nebraska corporation and ASAR ELECTRONICS, INC., a Nebraska corporation (collectively, "Prior Assignees") (Inventor and Prior Assignees are collectively referred to herein as "Assignor") to ABEO, LLC a Delaware limited liability company, with its principal office located at 11717 Burt Street, Suite 208, Omaha, Nebraska 68154 ("Assignee").

RECITALS

WHEREAS, Inventor obtained letters patent of the United States of America for certain new and useful improvements concerning a riveting technology, mobile telephone relaying device and electronic safety blanket, which letters patent are more particularly described on Exhibit "A" which is attached hereto and incorporated herein by this reference;

WHEREAS, Inventor has also invented certain new and useful improvements concerning a riveting technology, mobile telephone relaying device and electronic safety blanket, for which Inventor has made applications for letters patent are more particularly described on Exhibit "A" which is attached hereto and incorporated herein by this reference;

WHEREAS, Inventor has previously assigned all or part of Inventor's right, title and interest in and to the letters patent and application for letters patent described on Exhibit "A" to Prior Assignees under separate assignments, one dated January 25, 2006 and one dated February 14, 2006 (collectively, "Prior Assignments")

WHEREAS, Inventor and Prior Assignees are now the sole and exclusive owners of the letters patent and applications, and of all rights in same; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the letters patent and the applications for letters patent, unconditionally and without reservation to either Inventor or Prior Assignees.

NOW THEREFORE, in consideration of the foregoing, the various transactions set forth in that certain Letter of Intent dated January 25, 2007 to which Assignor is a party ("Letter of Intent") which transactions are being consummated contemporaneous with the execution and delivery of this Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

ARTICLE I ASSIGNMENT

In consideration of the consummation of the transactions set forth in the Letter of Intent, and other valuable consideration, Assignor assigns to Assignee the inventions, the letters patent and the applications for letters patent, and any reissue or reissues of the same, both in the United States of America and internationally (except with respect to App. 11/261,934 which is U.S. only), to be held and enjoyed by Assignee for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, to the end of the term or terms for which the letters patent are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by Inventor or Prior Assignees if this Agreement had not been made, together with all claims for damages by reason of past infringement of the

letters patent, with the right to sue for and collect the same for Assignee's own use, and for the use of Assignee's successors, assigns, or other legal representatives.

ARTICLE II AUTHORIZATION AND REQUEST

Assignor authorizes and requests the Commissioner of Patents and Trademarks to issue any and all letters patent of the United States on the inventions or resulting from the applications, or any division or divisions of the same, to Assignee as assignee of the interest assigned by this Agreement.

ARTICLE III COOPERATION

Inventor and Prior Assignees agree that they will at any time upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the inventions or any letters patent that are or may be granted for the same. Inventor further agrees that he will at any time on request communicate to Assignee any facts relating to the inventions and letters patent or the history of the same and testify as to the same in any interference or other litigation when requested to do so.

ARTICLE IV ASSIGNOR'S WARRANTY

Inventor and Prior Assignees represent, warrant and covenant unto Assignee that they have full right to convey the interest assigned by this Agreement, and that they have not executed and will not execute any agreement that is in conflict with this Assignment. To the extent that any provision of the Prior Assignments are inconsistent with or in conflict with the terms of this Agreement, Inventor and Prior Assignees warrant unto Assignee that the terms of this Agreement shall control.

ARTICLE V ADDITIONAL ASSIGNOR

James P. Eggers hereby enters into this Agreement, as an additional Assignor, subject to all of the terms and provisions of this Agreement, with respect to that certain application for letters patent identified on Exhibit "A" for which he is listed as an additional inventor.
