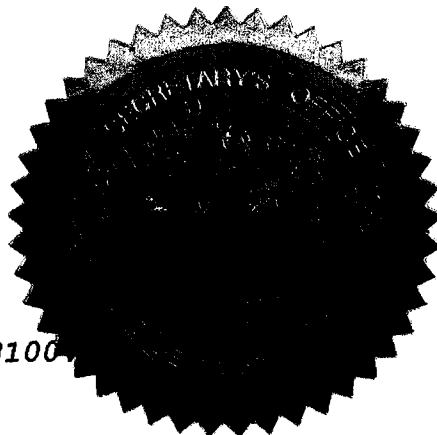

1. The name of the Corporation is Bristol-Myers Squibb Pharma Research Labs, Inc. Upon the filing of the Corporation's original certificate of incorporation, the name of the Corporation was CombiChem, Inc.
2. The name of the Delaware limited liability company into which the Corporation shall convert as set forth in its certificate of formation filed in accordance with Section 18-201 and Section 18-214(b) of the Delaware Limited Liability Company Act (the "Act") is BMSPL, L.L.C.
3. The conversion to a limited liability company contemplated by this Certificate of Conversion has been approved by the sole stockholder of the outstanding stock of the Corporation acting by written consent in lieu of a meeting pursuant to Section 228 of the Delaware General Corporation Law.
