## **PATENT ASSIGNMENT AGREEMENT**

This Patent Assignment (the "**Assignment**") is made as of March 12, 2007, by and among VERISIGN, INC., a Delaware corporation ("**Assignor**"), PAYPAL, INC., a Delaware corporation ("**Assignee**"), and PAYPAL INTERNATIONAL LIMITED, a company incorporated in the Republic of Ireland and a wholly owned subsidiary of Assignee ("**International**" and together with Assignee, "**Assignees**").

### **RECITALS**

A. Pursuant to the Asset Purchase Agreement, dated as of October 10, 2005, by and among Assignor, eBay, Inc., a Delaware corporation ("**eBay**"), and Assignees (the "**Purchase Agreement**"), Assignor has agreed to sell its payment services business to eBay and Assignees. All capitalized terms used, but not specifically defined herein shall have the meaning ascribed to them in the Purchase Agreement.

B. Pursuant to Section 1.1(a) of the Purchase Agreement, Assignor desires to transfer and assign to Assignees all of Assignor's worldwide right, title and interest in and to the patents, patent applications and patent rights to inventions (including counterparts, reissues, divisions, extensions, continuations and continuations in part thereof) which are set forth in **Schedule A** attached hereto.

### **AGREEMENT**

NOW, THEREFORE, in consideration of the foregoing and the covenants and agreements set forth herein, the parties hereto agree as follows:

1. Immediately subsequent to the Closing Date, Assignor hereby assigns, transfers and conveys to Assignees for itself and its successors, transferees and assignees, (a) the entire worldwide right, title, and interest in and to the patent applications and patents set forth in **Schedule A** attached hereto, including (i) any right of priority; (ii) any divisional, continuation, substitute, renewal, reissue, and other related applications thereto which have been or may be filed in the United States or elsewhere in the world; (iii) any and all patents (including reissues and re-examinations) which may be granted on the applications and patents set forth in (i) and (ii) above; and (iv) the right to sue in its own name, collect and recover damages for infringement (including past infringement) of any or all of the foregoing patent rights (collectively, the "**Patent Rights**").

2. Upon Assignees' reasonable request, Assignor agrees to execute all oaths, assignments, powers of attorney, applications, and other papers reasonably necessary to fully secure to Assignees the rights, titles and interests herein conveyed. Assignor further agrees to provide any successor, assign, or legal representative of Assignees with the benefits and assistance provided to Assignee hereunder.

3. This Assignment shall be governed by, and construed in accordance with the laws of the State of California without reference to such state's principles of conflicts of law.


