I do hereby authorize and request the Commissioner of Patents to issue the Letters Patent(s) to the Assignee in accordance herewith.

I hereby authorize the Assignee, its successors and assigns or anyone it may properly designate, to insert in this instrument the filing date and Application No. of the application when ascertained.

I further authorize the Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name, if desired, in any and all

foreign countries, and additionally to claim the filing date of the United States application and/or otherwise take advantage of the provisions of the International Convention.

I do hereby covenant and agree with the Assignee, its successors and assigns, that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I or my executors or administrators will, at any time upon request, without further or additional consideration, but at the expense of the Assignee, its successors and assigns, execute such additional writings and do such additional acts as the Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, continuation, divisional, reissued, reexamined, substitute or extended Letters Patent(s) of the United States, or of any and all foreign countries on the invention, and in enforcing any rights, occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.
