I, Matthew T Jarman of 3830 South 3100 East, Salt Lake City, UT 84109, have invented a method and apparatus entitled DELIVERY OF NAVIGATION DATA FOR PLAYBACK OF AUDIO AND VIDEO CONTENT hereinafter called the "invention."

Cooperation to the best of my ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.

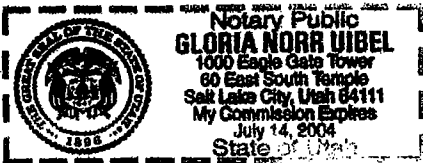
