## U.S. PATENTS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of May 11, 2007, by Credit Suisse, as Collateral Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Second Lien Credit Agreement dated as of January 27, 2006 (as amended, supplemented or otherwise modified from time to time prior to the date hereof) (the “**Existing Credit Agreement**”), among Deluxe Entertainment Services Group Inc. (the “**Borrower**”), DX Holdings LLC (“**Holdings**”), the lenders from time to time party thereto (the “**Lenders**”), Credit Suisse, as administrative agent and as collateral agent (in such capacity, the “**Collateral Agent**”) and the other agents thereunder.

B. Reference is made to the Second Lien Guarantee and Collateral Agreement, dated as of January 27, 2006 (the “**Guarantee and Collateral Agreement**”), among Holdings, the Borrower, the subsidiaries of the Borrower party thereto and the Collateral Agent, pursuant to which, among other things, the Borrower granted a security interest to the Collateral Agent, for the benefit of certain secured parties named therein, in, among other things, all letters patent and applications for letters patent of the United States or the equivalent thereof in any country, including registrations, recordings and pending applications of the Borrower and certain of its subsidiaries set forth on Annex I hereto (the “**Patents**”), which security interest was recorded with the United States Patent & Trademark Office against certain Patents at Reel 017519 Frame 0848, on April 26, 2006.

C. In connection with the termination of the Credit Agreement, the Borrower has informed the Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, the Lenders and each other grantee or beneficiary in and to the Patents granted under the Guarantee and Collateral Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent’s right, title and interest (including, without limitation, security interests) in and to the Patents pursuant to the Guarantee and Collateral Agreement shall automatically terminate as provided in the Guarantee and Collateral Agreement, including, without limitation, the Patents set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Collateral Agent in such Patents shall hereby cease and become void.
