### ASSIGNMENT

WHEREAS, we, Ambrose C. T. Thompson a citizen of the United Kingdom residing at the address as stated below, and Peter F. Lawrence, a citizen of the United Kingdom residing at the address as stated below, have invented an ornamental design for a "Loudspeaker" for which we have executed an application for United States Letters Patent filed concurrently herewith.



I represent and covenant that no assignment, mortgage, sale, license, pledge, encumbrance or alienation of said invention or patent application has been or will be made or entered into which would conflict with this assignment and sale.


I hereby authorize and request the Commissioner for Patents of the United States to issue all Letters Patent based on said application and each division, continuation, substitution, reissue, renewal and extension thereof to said ASSIGNEE, its successors and assigns.
