ASSIGNMENT DOCUMENT

THIS ASSIGNMENT is made and entered into by and between Richard C. rights of priority resulting from the filing of said Application and applications; and all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said Invention.

ASSIGNOR hereby authorizes and requests the Director of the U.S. Patent and Trademark office and all foreign Patent Offices to issue Patents for the subject matter assigned herein to ASSIGNEE for the sole and exclusive benefit of ASSIGNEE to the full end of the term for which said Patent may be granted as fully and entirely as the same would have been held by ASSIGNOR had this assignment and sale not been made.



to secure ASSIGNOR's signature on any documents relating to protection or maintenance of the subject matter assigned herein to ASSIGNEE, whether because of ASSIGNOR's physical or mental incapacity or for any other reason whatsoever, ASSIGNOR hereby irrevocably designates and appoints ASSIGNEE and ASSIGNEE's duly authorized officers and agents as his agent and attorney-in-fact, to act for and on his behalf to execute and file any patent application or applications and to do all other lawfully permitted acts to further the protection and maintenance of the subject matter assigned herein to ASSIGNEE with the same legal force and effect as if personally executed by ASSIGNOR.
