**ASSIGNMENT**

WHEREAS, Henrik Glent-Madsen, residing at Lysmosevej 6, DK-8670 Låsby, Denmark respectively hereinafter referred to as Assignor, has invented certain new and useful improvements in METHOD FOR ESTABLISHING A LIGHT BEAM WITH SUBSTANTIALLY CONSTANT LUMINOUS INTENSITY for which an application for United States Letters Patent was filed on September 14, 2006 and assigned Application No. 10/598,918.

FURTHER, Assignor agrees to communicate to said Assignee or its representatives any facts known to Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States.
