AND ASSIGNOR HEREBY covenants that ASSIGNOR has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith, and conveys all rights to sue for any past infringement under the said invention.

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to ald ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection, Plant Variety Protection and Plant Breeder's Rights protection for said invention in all countries.
