Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST. The name of the surviving corporation is **AGILE RF, INC.**, a Delaware corporation, and the name of the corporation being merged into this surviving corporation is **AGILE MATERIALS AND TECHNOLOGIES, INC.**, a California corporation.

SECOND. The Agreement of Merger dated as of April 26, 2007 (the "Agreement of Merger"), has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.

THIRD. The name of the surviving corporation is Agile RF, Inc., a Delaware corporation.

FOURTH. The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

FIFTH. The authorized stock of the disappearing California corporation is one thousand (1,000) Common Stock, par value \$0.01 per share.

SIXTH. The merger is to become effective on April 27, 2007.

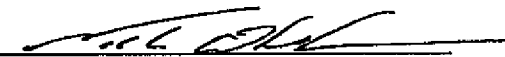
SEVENTH. The executed Agreement of Merger is on file at the principal place of business of the surviving corporation, at 93 Castilian Drive, Goleta, California 93117.

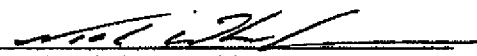
