**CERTIFICATE OF AMENDMENT  
TO THE CERTIFICATE OF INCORPORATION  
OF FIRST AMERICAN CORELOGIC, INC.**

First American CoreLogic, Inc., a Delaware corporation (the "Corporation"), originally incorporated on January 30, 2007 under the original name of "CoreLogic, Inc.," a corporation organized and existing under the Delaware General Corporation Law, hereby certifies as follows for the purposes of amending its Certificate of Incorporation:

FIRST: Through the Certificate the Merger the Corporation's name was changed to First American CoreLogic, Inc. on February 2, 2007.

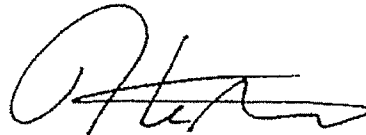
