

Course of the procedure

With effect from October 1, 2006, *mr* J.E. Biesma succeeds *mr* P.W.T. Buijtenhuijs as delegated judge in the above-mentioned involuntary liquidations and debt rescheduling arrangements.

Legal ground

Having regard to the above, the court shall appoint *mr* J.E. Biesma as delegated judge in the place of *mr* P.W.T. Buijtenhuijs in the above-mentioned involuntary liquidations and debt rescheduling arrangements.

Decision

The court:

discharges *mr* P.W.T. Buijtenhuijs as delegated judge in the above-mentioned involuntary liquidations and debt rescheduling arrangements;

appoints *mr* J.E. Biesma as delegated judge in the above-mentioned involuntary liquidations and debt rescheduling arrangements.
